Speaker(s): Al Redmer, Jr. – Md. State insurance commissioner. Gave definitions of insurance and purpose. State agencies to protect all of us with regulating what is in industry. Insurance companies are the supporters of this program. Insurance are legal contracts between client and insurer. We finance them two ways every 5 years we examine their financials thoroughly, we monitor them to be sure they are not in financial distress. Secondly we approve rates based on data that the premiums meet the increase needed. Risk factors determine premiums. We deal with the complaints from the consumer. Law regulates terms of policies and they must be followed. There are appeal options. We also do targeted examines driven by complaints. Visit our website and examine the resources that are available and locations that we are available at local events. As a result of Isabell we established a disaster recovery to assist with disasters that helped with all the lesson learned from Isabell. We also help to facilitate claims with federal government insurance policies. Fraud insurance is an issue in Maryland. We help with these issues. Add competition to state, 150 new carriers for choices of insurance. The affordable care act has been problematic but has begun to be stabilize. We don't have the talent in Maryland for Insurance learning. We have finally, working with a college to develop a pool to get the talent from.
